- **Easler/Holliman/OGR** – Preliminary design will be sent to Williamsburg County with additional information.

**Rural Planning Work Program (RPWP)**

The draft will be put out for a twenty-one (21) day public comment period prior to being presented to the WRCOG Board of Directors for adoption.
