Welcome and Introductions - Ms. Tucker welcomed the committee members and noted a quorum was present.

Meeting Summary - Ms. Tucker presented the September 14, 2022 meeting summary. There was one correction to the SCDOT Performance Measures Safety Targets to indicate the performance years to 2019-2023. No other corrections made.

Projects Update

Mr. Johnson from SCDOT gave a projects update:

- **SC 41, Big Dam Swamp (Georgetown)** – ROW has been established and currently working on preliminary data. SCDOT will be reaching out to Georgetown County with additional information.
- **US52 at Eastland (Williamsburg County)** – In the process of gathering data; on track for 2025 construction estimate.
- **Easler/Holliman/OGR** – In house design; RRSA currently addressing the side roads.

Rural Planning Work Program (RPWP)

Ms. Tucker presented the WRCOG RPWP revision. SCDOT has increased the annual funding for the rural program for FY22-23. Ms. Tucker explained the RPWP defines how funding will be utilized in each fiscal year and the tasks that will be performed. The plan revision indicates the annual increase as well as the task allocation for those funds.
