

NOTICE TO THE CITIZENS OF GEORGETOWN, HORRY, AND WILLIAMSBURG COUNTIES:

The Waccamaw Regional Council of Governments (WRCOG) is seeking comments on proposed amendments to the Rural Long Range Transportation Plan (RLRTP) and Rural Transportation Improvement Plan (RTIP). The amendment will include the 2020 – 2024 Safety Performance Targets and the 2018-2022 Performance Targets Assessment (Actual) as recommended by the South Carolina Department of Transportation (SCDOT) and the South Carolina Department of Public Safety, in accordance with the Fixing America’s Surface Transportation (FAST) Act. The proposed targets are:
